- Importance of training and development measures for staff retention
- Identification of development potential and creation of individual development plans
- Conducting staff and feedback interviews

Creating optimal working conditions for healthy cooperation:

- Importance of working conditions for employee retention
- Developing measures to improve working conditions
- Leadership and cooperation as important factors for employee retention
